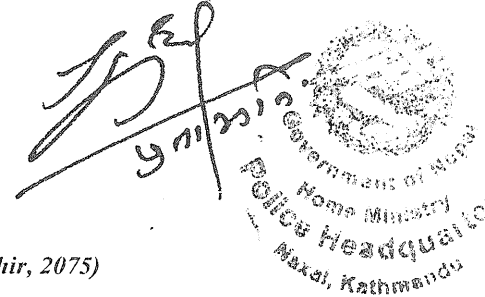


Invitation for Bids

Bidding documents (For the items mentioned above From S.N. 4 to 8) may be purchased from the office of *PHQ, Naxal, Kathmandu* by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, copy of VAT/PAN registration certificate, Copy of Tax Clearance Certificate F/Y 2073/74, Tax Clearance Certificate F/Y 2074/75 or evidence of extended deadline for submission tax of F/Y2074/075 and upon payment of a non-refundable fee as specified above on or before *06th January, 2019 (22nd Poush, 2075)* during office hours.
4. Bidder must submit their bid electronically (For the items mentioned above From S.N. 1 to 3) as per e-GP System Operation Guidelines, 2074. Bidder can download the bidding documents for e-submission form PPMO's website www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the account as specified below and the scanned copy (.pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

5. Pre-Bid Meeting shall be held at Police Head Quarters, Naxal on *26th December, 2018 (11th Poush, 2075)* at 14:00 hours.
6. Electronic Bids must be submitted to the *Procurement Section Police Head Quarters, Naxal, Kathmandu* through *PPMO's website: www.bolpatra.gov.np/egp* on or before *07th January, 2019 (23rd Poush, 2075)* at 12:00 noon. Documents received after this deadline shall not be accepted.
7. The Bids will be opened in the presence of Bidders' representatives who choose to attend *07th January, 2019 (23rd Poush, 2075)* at 14:00 hours at the office of *PHQ, Naxal, Kathmandu Nepal*. Bids must be valid for a period of *90 days* counting from the day of bid opening and must be accompanied by bid security, which shall be *valid for minimum 30 days* beyond the bid validity period.
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such case the bid validity and bid security shall remain the same as specified for the original last date of bid submission.
9. The Employer reserves the right to accept or reject, wholly or partially any or all the bids without assigning reason whatsoever.
