Bids must be valid for a period of 30 Days after bid opening and must be accompanied by a bid security of scanned copy if of the bid security in pdf format which shall be valid for 90-days beyond the validity of the bid (i.e. 04-May-2017).

If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

4. In case of e-submission of bid, the bidder should submit the original Bid Security Letter with complete Bid Document within seven days form bid submission deadlines.
