Documents received after this deadline shall not be accepted.

The Bids will be opened in the presence of Bidders' representatives who choose to attend **11<sup>th</sup> March, 2022 (27<sup>th</sup> Falgun, 2078 at 14:00 hours at Procurement Directorate, Police Head Quarters, Naxal, Kathmandu Nepal**. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security, which shall be **valid for minimum 30 days** beyond the bid validity period..
