3. Pre-bid meeting shall be held at **Nepal Police Central Forensic Science laboratory Samakhushi, Kathmandu** on **16th February, 2026 (4th Falgun, 2082)** at 14:00 hours.
4. Electronic bids must be submitted to the office **Nepal Police Central Forensic Science laboratory Samakhushi, Kathmandu** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **25th February, 2026 (13th Falgun, 2082)** at 12:00 hours. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **25th February, 2026 (13th Falgun, 2082)** at 14:00 hours at the office of **Nepal Police Central Forensic Science laboratory Samakhushi, Kathmandu**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the bid validity period of the bid.
6. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
