Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.

4. Bidder must submit their bid electronically as per e-GP System Operating Guidelines, 2080. Bidder may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below.

5. Pre-bid meeting shall be held Kathmandu Valley Traffic Police Office Ramshapath Kathmandu at 14:00 hours,5<sup>th</sup> February, 2024 (22<sup>nd</sup> Magha, 2080)

6. electronic bids must be submitted to the office *Kathmandu Valley Traffic Police Office Ramshapath Kathmandu* through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 on 21st February, 2024 (9th Phagun, 2080). Bids received after this deadline will be rejected.

7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours, 21st February, 2024 (9th Phagun, 2080)] at the office of Kathmandu Valley Traffic Police Office Ramshapath Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid.

8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
