- 5. Electronic bids must be submitted to the office *Nepal Police Central Forensic Science laboratory Samakhusi, Kathmandu* through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 2nd October, 2024 (16thAshoj, 2081) at 12:00 hours. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 2nd October, 2024 (16thAshoj, 2081) at 14:00 hours at the office of Nepal Police Central Forensic Science laboratory Samakhusi, Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the bid validity period of the bid.
