IMPORTANT INFORMATION

1. Bid Documents: Complete Bid Documents may be obtained from the Procurement Section, **Gandaki Province Police Hospital, Pokhara, Kaski**, during office hours upon submission of a written application signed by the proprietor, authorization letter, attested copies of Firm/Company Registration Certificate, VAT/PAN and Tax Clearance Certificate of fiscal year 2081/082 or evidence of tax return submission, applicable licenses/registrations, Bid Security, original bid-fee voucher/receipt of the prescribed **non-refundable fee of NPR 1,000.00. (One thousand Each)** and other documents specified in the Bid Documents.

2. Submission: Sealed bids shall be physically by hand submitted to the Procurement Section within 7 (Seven) days from the date of first publication. **Last Date: 24th September 2026 (8th Aswin 2083 BS) Time: 12:00 hrs Noon.** Bids received after this deadline will be rejected.

3. Opening: Bids shall be opened **24th September 2026 (8th Aswin 2083 BS)** at **14:00 PM** on the same day at the Hospital in the presence of bidders or their authorized representatives.

4. Validity & Security: Bid Security of the amount specified in the respective bidding document shall be submitted in an acceptable form, including a Bank Guarantee issued by an eligible commercial bank, as prescribed in the bidding document and Bids shall remain valid for 45 days after bid opening and shall be accompanied by Bid Security of the amount specified for the respective package. Bid Security shall remain valid for 30 days beyond the bid validity period (i.e. 75 days).

5. Medicines: Medicines shall be **DDA and WHO GMP Certified** and manufactured in A.D. 2026 or have at least 75% (seventy Five Percent) of remaining shelf life from the date of supply, and shall meet the prescribed generic name, strength, dosage form, pack size, quality standard, batch/lot number, manufacturer, storage condition and other technical requirements.

6. Other Items: Laboratory Reagents, X-Ray Films and Dental/Surgical Items shall strictly comply with the specifications, quantity, unit, quality standards and other requirements specified in the respective Bid Documents.

7. Evaluation: Bids shall be evaluated in accordance with the prevailing Public Procurement Act, Regulations, Bid Documents and prescribed evaluation criteria. The Hospital reserves the right to accept/reject any or all bids and cancel the procurement process, wholly or partially, as permitted by law.
