The Bids will be opened in the presence of Bidders' representatives who choose to 19th December, 2025 (4th Poush, 2082) at 11:00 hours at Nepal Police Heaquarters, Central Investigation bureau, Lazimpat, Kathmandu. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, which shall be valid for minimum 30 days beyond the bid validity period.
